# **Call to Order and Invocation**

Mayor Russell called the meeting to order at 7:00 pm.

Councilman Welch leads the Lord's Prayer and Pledge of Allegiance.

# Guests:

Guy Parks- Eastern Shore Hockey League- Mr. Parks informed the council of a tree hanging over the hockey court that they'd like to have trimmed (at their expense). Mr. Parks was given permission by the council to have the tree and stump removed. The council thanked them for doing so.

Ellen Johnson- ESRM- Mrs. Johnson thanked everyone who helped with the Ice Cream Social event, which had over 200 people in attendance. Mrs. Johnson noted that the Rails to Trails program donated \$165.00 to the ESRM. Mrs. Johnson noted that a representative from the Delmarva Poultry Industry reached out to her regarding an annual picnic event to be held here at the ESRM for farmers and produce growers on the East Coast.





K. Eichelberger- 24255 Adelaide St.- Mrs. Eichelberger thanked the public works department for limbing and repairing the alleyway and also for cleaning up the limbs, stumps, and brush debris. Mrs. Eichelberger noted the limbs had grown back over the alley.

#### **Department & Council Reports:**

Mayor Russell- Mayor Russell stated he had received several noise complaints from the music playing at the revival Sunday evening. The Mayor suggested guidelines for the pavilion/stage rental be discussed at the upcoming June 22, 2024 work session.

Chief Greer- Nothing to report.

Councilman Nicholson- Councilman Nicholson spoke about the solar speed limit signs: The trailer has been assembled. Robbie Byrd needs to be contacted to put uprights on it. He noted that both of the signs would not fit on one the trailer. He asked the council if they wanted to purchase another trailer of the same kind from Harbor Freight. All the council agreed to purchase a second trailer of the same kind. A vote was not taken as it's still within the allowable budget previously noted. Councilman Nicholson spoke about the LSLI project. They started the work today. The public works employees are marking blue lines, noting where the line is. Councilman Nicholson stated he spoke to Mr. Dirk Lynch of MSA regarding the payment schedule. It is as follows: First payment with work completion of 25%, Second payment with 50% (more) of the work completed, and third payment once the remaining 25% of work is complete and all documentation is submitted.





Clerk Lewis- Nothing to report.

Councilman Layne- Councilman Layne stated he had reported the open septic tank to VDH twice and reported it. Councilman Nicholson stated he would look at it tomorrow.

Councilman Taylor- Councilman Taylor stated the ES Cruisers are hosting a car show on Saturday, August 17, 2024 from 10-2. They're requesting use of the front parking lot and the parking lot area immediately to the East of that lot. Councilman Taylor made a motion to allow them to host the event once the paperwork is filled out at the Town Office. Seconded by Councilman York.

Councilman S. Welch- Nothing to report.

Councilwoman J. Welch- Councilwoman Welch stated she and Mrs. K. Eichelberger were working on the bench idea for the library.

Councilman York- Regarding the personnel committee, Councilman York stated that they'd need to enter an executive session to discuss the town office vacancy. Councilman York said he was going to the voluntary FOIA training hosted by VML in Eastville. He noted the upcoming Health Fair to be held on August 3, 2024. Councilman York asked Councilman Nicholson if limb/yard debris pickup was on schedule. Councilman Nicholson stated currently there isn't a set schedule due to weather and availability. Councilman York mentioned a business he'd seen posted on Facebook, "Paint the Wood," that was based in Parksley. He inquired if they had a business license. Clerk Lewis informed him they do not.

Councilman York made a motion to enter the executive session at 7:42 pm for personnel and legal reasons, requesting Clerk Lewis to attend. Seconded by Councilman Layne.
